The Trading Dispute Committee Findings are:

Excessively large erroneous Annualised Advances (AAs) and Estimates of Annual Consumption (EACs) have entered Settlement, affecting the Non-Half Hourly (NHH) market. The TDC has authorised the performance of Post-Final Settlement Runs to correct this Settlement Error for the above period.

The TDC has reviewed the Settlement Error arising within the affected GSP Groups and has determined that Post-Final Settlement Runs will not be performed in the following GSP Group(s) from the Settlement Days set out below.
