

P272 – ALTERNATIVE LEGAL TEXT

SECTION L: METERING (v14.0)

Amend paragraph 2.2 to read as follows:

2.2 Type of Metering Equipment

2.2.1 The Metering Equipment to be installed:

- (a) in the case of a CVA Metering System, shall be Half Hourly Metering Equipment;
- (b) in the case of a SVA Metering System which is 100kW Metering System, shall be Half Hourly Metering Equipment;
- (c) in the case of a SVA Metering System associated with any Third Party Generating Plant, except in the case of a Small Scale Third Party Generating Plant, shall be Half Hourly Metering Equipment;
- (d) in the case of a SVA Metering System other than as provided in paragraph (b) ~~and~~, (c) and 2.2.2, shall be Half Hourly Metering Equipment or Non-Half Hourly Metering Equipment as the Registrant shall choose.

2.2.2 Where a Supplier is under an obligation in its Supply Licence to install an Advanced Meter at a premises and/or supply electricity to a premises through an Advanced Meter then:

- (a) prior to 1 April 2015 the Advanced Meter shall, for the purposes of the Code, be deemed to be either Half Hourly Metering Equipment or Non-Half Hourly Metering Equipment as the Registrant shall choose; and
- (b) as from 1 April 2015 the Advanced Meter shall be Half Hourly Metering Equipment.

2.3 New Metering Systems

Amend paragraph 2.3.3 to read as follows:

2.3.3 Without prejudice to any other right of other Parties, if the Registrant of a new SVA Metering System within paragraph 2.2.1(b), ~~or~~ (c) or 2.2.2 fails to ensure that Metering Equipment is installed and commissioned in accordance with paragraph 2.1.1(a) before the registration of the Metering System becomes effective, he shall be liable to a charge to be determined and payable in accordance with Annex S-1.

SECTION S: SUPPLIER VOLUME ALLOCATION (V19.0)

2. RESPONSIBILITIES OF SUPPLIERS AND SUPPLIER AGENTS

2.6 Provision of Data

Insert new paragraph 2.6.1A after 2.6.1 to read as follows:

2.6.1A In respect of each SVA Metering System which is an Advanced Meter in relation to which it is registered with a Supplier Meter Registration Agent, a Supplier shall submit, or procure the submission of, the appropriate data (as specified by BSCP01 (Overview of Settlement Process)) to the SVAA promptly after collection of such data and, in any event:

(a) in respect of the data from Settlement Days before 1 April 2015, before the relevant Final Reconciliation Volume Allocation Run; and

(b) in respect of the data from Settlement Days on or after 1 April 2015, before the relevant First Reconciliation Volume Allocation Run,

in each case, in accordance with BSCP01 (Overview of Settlement Process).

Amend paragraph 2.6.2 to read as follows:

2.6.2 In respect of each SVA Metering System which is not a 100kW Metering System or an Advanced Meter in relation to which it is registered with a Supplier Meter Registration Agent, a Supplier shall submit, or procure the submission of, the appropriate data (as specified by BSCP01 (Overview of Settlement Process)) to the SVAA promptly after collection of such data and, in any event, before the relevant Final Reconciliation Volume Allocation Run, in accordance with BSCP01 (Overview of Settlement Process).

ANNEX S-1: PERFORMANCE LEVELS AND SUPPLIER CHARGES (v7.0)

2.2 Energy and Metering Systems on Annual Advances and Actual Readings at Each Volume Allocation Run - Serial SP08

Amend paragraph 2.2.8 to read as follows:

2.2.8 In relation to each GSP Group and in respect of Half Hourly Metering Systems for which a Supplier is responsible which are identified as not being 100kW Metering Systems, the Supplier shall ensure, subject to paragraph 2.2.8A, that (in accordance with the relevant BSC Procedure) in respect of each month actual (rather than estimated) values in respect of not less than 99 per cent. of the total energy attributable to that Supplier relating to such Metering Systems for the aggregate of the Applicable Settlement Periods are provided by its Half Hourly Data Aggregator to the SVAA in time for the relevant Final Reconciliation Volume Allocation Run.

Insert new paragraph 2.2.8A after 2.2.8 to read as follows:

2.2.8A Where any Half Hourly Metering Systems referred to in paragraph 2.2.8 are Advanced Meters and the data to be provided thereunder relates to Settlement Days occurring on or after 1 April 2015 then the Supplier shall ensure that the actual values provided thereunder shall be provided in time for the relevant First Reconciliation Volume Allocation Run.

2.4 Installation of Half Hourly Metering - Serial SP04

Amend paragraph 2.4 to read as follows:

2.4.1 A Supplier shall comply with the requirements of Section L2.1.1 in relation to the installation of Half Hourly Metering Equipment for each 100kW Metering System for which it is responsible.

2.4.1A As from 1 April 2015, a Supplier shall comply with the requirements of Section L2.2.2(b) in relation to each Advanced Meter for which it is responsible.

2.4.2 The Performance Level set out in paragraphs 2.4.1 and 2.4.1A ~~is~~are referred to elsewhere in this Annex S-1 as Serial SP04.

ANNEX X-1: GENERAL GLOSSARY (v52.0)

Insert the following new definition into the general glossary in alphabetical order to read as follows:

"Advanced Meter": means Metering Equipment installed in accordance with the obligation set out in condition 12.18 of the Standard Conditions of each Supply Licence;
